As a member of the Noblesville SisterCities exchange group.....

1. I will cooperate with my chaperones and the adults in charge and honor the rules that they set for me regarding such things as curfew, punctuality, behavior on the tour and especially my behavior with my Cittadella host family.
2. I will dress and act appropriately at all times and be sensitive to the impression that I am conveying in a culture other than my own.
3. I will refrain from the use of tobacco, drugs and profanity. I will refrain from excessive alcohol consumption that does not include a glass of wine with dinner or an event put on by the SisterCities community. If a student is found breaking this agreement they will be sent home as they are there to represent their city and state.
4. For my own safety, I agree not to operate any motorized vehicle or be a passenger on any motorcycle.
5. I agree to remain under the supervision of my chaperone or host family and will not intentionally separate myself from the group.

Any student whose attitude or behavior is detrimental to the group or to themselves, and who repeatedly disregards chaperone instructions may be sent home before the end of the program at the parent’s expense. All efforts to solve the conflict, including a phone call to the parents, will be made prior to sending a student home.
